

MONOS X REFORMATION SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY

1. **SWEEPSTAKES TIMING:** The Monos x Reformation Giveaway (the "Sweepstakes") begins at 9:00 AM Pacific Time ("PT") on June 5, 2026, and continues through 11:59 PM PT on June 10, 2026 (the "Sweepstakes Period").
2. **ELIGIBILITY:** Open only to legal residents of Canada (excluding Quebec) who are eighteen (18) years of age or older at time of entry. Void where prohibited by law. Employees of LYMI, Inc. ("Sponsor"), the administrator of the Sweepstakes, their respective affiliates, subsidiaries, advertising and promotion agencies (collectively, the "Promotion Entities") and the immediate family members and/or those living in the same household of each are not eligible.
